European profile for Peer-supporter/ Program Erasmus+

The Erasmus + project “European Profile for Recovery Companions” emerged from the initiative of the Cordaan Foundation and Mr. Marcel Carpaij. In the Netherlands, the idea of peer support was already strongly developed when the application was submitted. Since the project leader Grone had the necessary experience in the context of the implementation of international projects, the project management as well as the application were moved to the German partner. The other partners from Norway, Greece and Poland were then invited to participate in the project based on their experience and the specialist knowledge they had on the project topic.

- **The project was subsidized by the National Agency in Germany as part of the Erasmus + Strategic Partnerships for Innovations program**
- **The project includes two major priorities from the Erasmus + program:**

- **The project will run from September 1st, 2019 to December 31st, 2021**
